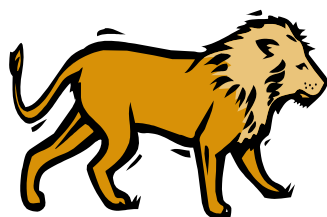

The school phone is a business phone. Students may use the phone for emergency calls only. Please do not call our office with a message to a student after 2:00 p.m. We cannot insure that dismissal changes are communicated in time, unless advance notice is given. **If at all possible, please make arrangements through notes to the teacher.**

School Police Officer, Locked Door Policy and Visitors.....

The School Protection Officer program in Vigo County employs special police officers at each school. The goal is to provide a safe and effective learning environment at every school. The officer has training that is provided by the Law Enforcement Academy or the Sheriff’s Department and a special orientation involving school rules and procedures. The police officer is present to deter crime or violence but also to maintain a calm and civil atmosphere. We ask your assistance in this matter.

In the interest of school safety, all doors, except the main entry, will be locked. **There will be NO lunch/cafeteria visitors for the 2021-2022 school year.**

Parking in the front bus area is prohibited during the following times:

SCHOOL BUS TRANSPORTATION

Masks will be REQUIRED for all students

riding the bus during the 2021-22 school year. Lost Creek families are encouraged to utilize the transportation services provided by the VCSC. School bus travel is both safe and convenient and reduces the long traffic lines at the back door.

Lost Creek bus drivers have the important responsibility of keeping your child(ren) safe as they are transported to and from school. It is critical that your child(ren) follow the school bus safety rules. They can suspend students from the bus after parent notification. Your support is greatly appreciated. If you have concerns, compliments, or complaints, please call Transportation (462-4341).

BUS CHANGES AT DISMISSAL

If your child is to ride a different bus than the regular assigned one, s/he must bring a note from home giving the new bus number and the date(s) that the child is to ride. The note must be initialed by office staff and shown to the classroom teacher.

Textbook Fees

All fees are due within 10 days of enrollment. A payment plan can be arranged. The textbook rental fee is waived for students approved for "Free or Reduced" meal status. An application must be on file each school year.

SCHOOL AGE CHILD CARE-YMCA

Before School Hours: 6:30-8:00am

After School Hours: 2:45-6:00pm

Join the Vigo County YWCA for before and after school care at Lost Creek. All elementary school children (4-12) are welcome to participate. Additional information about the cost of the program can be obtained through the YMCA or at Lost Creek.

SCHOOL ENTRY

Children who are 5 years old by August 1 are eligible for Kindergarten in the 2020-21 school year. Registration is to take place on the VCSC website.

School Improvement Plan

Lost Creek was fully accredited through a Quality Assurance Review process in March, 2018. AdvancED serves as the parent organization for NCA CASI (North Central Association Commission on Accreditation and School Improvement) and two other national school accreditation agencies. Our five-year accreditation is evidence of our commitment to meet high standards, engage in school improvement focused on student performance, and participate in a third party review.

Each year, the Lost Creek School Improvement Team reviews the existing Lost Creek School Improvement Plan and analyzes student data. Lost Creek's goals for school improvement are:

1. ELA-All students will improve their ability to read and comprehend text across the curriculum.
2. Math - All students will increase problem solving abilities with a focus in Geometry and Measurement.

PERMITS

Permits and Out of County Cash Tuition: Students are required to attend the school in the district of their legal residence. If a parent wishes for a student to attend another elementary school, a permit application is required.

STUDENT RECORDS

Records that are maintained by the school may only be released to parents (natural biological parents) or legal custodians under FERPA guidelines. The records are not available to grandparents, other relatives or stepparents unless those individuals are legal custodians or a legal adoption has taken place.

COVERED BRIDGE SPECIAL EDUCATION SERVICES

The Covered Bridge Special Education District serves the Vigo County School Corporation. This organization provides services in testing students for any type of special learning problem. Placement in a program depends on eligibility criteria, which are determined using state and federal guidelines as well as local procedure.

A Student Assistant Team (S.A.T.) meets to establish general education interventions including parent notification and attempts to remediate at school. If the SAT committee determines that a referral for testing is necessary, then parents will be contacted for a Referral Conference. A Case Conference will be held after the testing is complete to determine eligibility and programming.

SAFETY DRILLS

Lost Creek has many safety drills that are done routinely, including fire and tornado drills. We also have periodic code drills in order to practice what to do in case of a threatening or an emergency situation.

SCHOOL DISCIPLINE PLAN

All children are expected to behave appropriately while at school. Incidents of poor behavior will be handled in the classroom when appropriate. Chronic behavior problems will be referred to the principal. Parents will be notified when the behavior is severe or chronic.

CLASSROOM RULES

Each classroom has its own rules developed by the teachers and students. Classroom expectations are posted in classrooms and a copy is given to the principal.

Seclusion and Restraint:

The Vigo County School Corporation supports the Seclusion and Restraint plan as adopted by the Covered Bridge Special Education District. The use of such is a last resort and as a means to maintain a safe and orderly environment to the extent to preserve the safety of students and others. The parents of the students involved will be notified verbally as soon as possible but preferably by the end

of the school day when the incident took place. There are other details in the plan that are available upon request.

BULLYING

In accordance with state law, "bullying" is prohibited in the Vigo County School Corporation. Bullying is defined as any act of threatening or intimidating behavior with the intent to harass, ridicule, humiliate, intimidate or harm another student. This includes engaging in the act of bullying while using school provided equipment or property. The act of "bullying" means overt, repeated acts or gestures that may be verbal, written communications or physical acts or any other behavior that fits the definition above.

Schools in the Vigo County School Corporation are encouraged to engage students, staff and parents in meaningful discussions about the negative aspects of bullying. The parent involvement may be through parent organizations already in place in each school. Parents or students who suspect that repeated acts of bullying are taking place should report the matter to the school principal or designee. ***The report or complaint shall name the alleged violator as well as the complainant.***

Upon receiving the report, the principal/designee will investigate the matter at the building level and school consequences will be assessed, as appropriate, according to Rule XII under Student Rights and Responsibilities. A report of the investigation and consequences shall be made available to the Director of Secondary and Elementary Education, as appropriate as well as the Coordinator of Student Services.

False Reporting: A person who knowingly makes a false complaint of a violation of this policy is subject to disciplinary action.

The Superintendent will ensure that this policy is disseminated throughout the school community. The Superintendent is authorized to develop all procedures and forms necessary to administer this policy. Adoption date: August 8, 2005

FIREARMS ON SCHOOL PROPERTY

The State Law concerning the crime of possession of firearms on school property has changed. A person who is legally able to possess a firearm may do so if the firearm is locked in the trunk of the person's motor vehicle or kept in the glove compartment of the person's locked motor vehicle or stored out of plain sight in the person's locked motor vehicle. A person who knowingly, intentionally, or recklessly leaves the firearm in plain view in a motor vehicle that is parked in a school parking lot commits a Class A misdemeanor.

A person in possession of a firearm in a school building or at a school event or on a school bus or on school grounds outside of the person's locked vehicle commits a Level 6 felony. Thus, weapons are not permitted on school property with the exceptions noted above by State Law.

Vigo County School Corporation Dress Code Guidelines Elementary Revised 2015

Appropriate dress in an elementary school has an effect upon the attitude of a student toward school and his/her schoolwork. Let us always dress in a fashion that will reflect the pride we feel in our school.

1. No shorts or skirts are to be worn that are shorter than mid-way on the thigh. This includes slits in skirts.
2. Sleeveless tops are allowed as long as they don't reveal undergarments or the lack of undergarments. No shirts of sheer materials are to be worn. No cut-off shirts or tops with bare midriffs, low necklines or bare backs are to be worn. Leggings must be covered with an article of clothing that is at least mid-way on the thigh in length.
3. No sunglasses, hats, hoods on sweatshirts, caps, or full head coverings are to be worn in the building before or during school hours. This does not include headwear worn for religious or documented medical purposes.
4. No article of clothing or accessory will be allowed that promotes, encourages, or

advertises alcohol, drugs, tobacco products, violence, gang-related activities and/or sexual content. Clothing that intimidates, threatens, or disgraces a fellow student or staff member by means of a symbol or sign is not allowed.

5. Students are not allowed to wear spiked chains, bracelets, belts, etc. In addition, pocket or wallet chains are also not to be worn.
6. No jeans/pants with rips, tears, or holes above mid-way on the thigh or long fringe are allowed. Jeans are to be worn no lower than hip level. Apparel is to be appropriate and not present a danger to other students.
7. No sagging is permitted. Any clothing which reveals undergarments, or the lack of undergarments will be considered inappropriate.
8. No sleep-wear clothing or slippers (unless on specified days).
9. All dress code guidelines apply to the bus ride to and from school as well.
10. The administration reserves the right to judge any student's dress appropriate or inappropriate and the prerogative of handling the situation as deemed necessary.

Public schools are supported by local, state, and federal courts in determining acceptable dress to be worn during school.

DRESS FOR THE WEATHER

Dressing appropriately for the weather is necessary. Generally speaking, we will participate in outside recess activities most days in the spring, fall, and some winter days. In most cases if the wind chill is above 25°, and there is no precipitation, then recess will be outdoors.

For safety, students wearing flip flops or sandals will not be able to climb on play equipment or run on the Pride Path.

Media Release of Directory Information

Please refer to **Policy JO-E** that allows directory information to be released to media organizations without the consent of parent or student. **Please refer to Policy JO-E for more specifics if needed.**

SCHOOL LUNCHES

The children may choose a full lunch with an alternative entree selection from the hot lunch line each day. When available, students may purchase additional food items. Parents are encouraged to pay for meals in advance by applying money to the student's account.

FREE AND REDUCED LUNCH PROGRAM

Parents who think they may meet the income guidelines are encouraged to apply for meal assistance programs. Forms are available at the school office. Textbook rental fees may also be waived as part of this process. Free or reduced lunches cannot be provided until the forms are filled out and approved, unless a child had been approved at another school in the Vigo County School Corporation. **Families must apply each year to receive meal benefits.**

CAFETERIA BEHAVIOR

Cafeteria assistants monitor student conduct in the lunchroom. The supervisors allow talking, but not unnecessary noise or poor behavior. Children are expected to sit in the lunchroom and to remain in their selected seat. Students who have a need, should raise their hand to get permission or help from the adult in charge. Incidents of poor behavior may result in loss of privileges or isolation during lunch period.

Lunches packed at home should not contain knives or glass containers. Please provide your child with a spoon from home.

Parents/guardians will not be able to eat with their children during the 2021-22 school year.

ABSENCES AND ILLNESSES

Parents are required to report absences to the school office by 10:00 a.m. on the day of the absence. **Refer to the VCSC Attendance Policy.**

MEDICATION

If a child needs to take medication at school, a form signed by the parent and the physician must be completed. This form is available in the office. Medication must be in a bottle from the pharmacy, properly labeled with the child's name and the name and dosage of the medication. All medication will be kept and administered in the nurse's office. Medication cannot be sent home on the bus with the child. Students are not permitted to carry any medication, over the counter or prescription, with them except in accordance with State Law.

THE SCHOOL NURSE

The school nurse is scheduled at Lost Creek one day each week and is available at other times as needed. A health assistant, certified in CPR and first aid, is available each day from 8:00 to 2:30pm. The health assistant may dispense medication and care for minor injuries and illnesses under the direction of the school nurse. Feel free to contact the school nurse for consultation regarding your child's health concerns or problems.

Vaccinations required for school attendance: Parents should have students immunized according to current state law and students may be excluded from school for non-compliance. A list of required vaccines is posted on the nurses' page of the V.C.S.C. website under Student Services.

HOMEWORK VIGO COUNTY SCHOOL CORPORATION STUDENT-PARENT GUIDE

Homework can be separated into three categories:

- A. Work to help review what was learned during the school day.
- B. Work to prepare for the next day - assignments, projects etc.
- C. Work to develop skills needed to help children learn and study.

Special assignments, projects and review for tests may add to the routine homework. Many times "homework" is simply unfinished school work.

REQUESTING HOMEWORK

If a child is absent for only one day, homework should not be requested as most can be made up the following day. If the anticipated absence will be for longer than a day, the teacher should be given plenty of notice to provide the requested assignments. Even if you call at 8:00 a.m. to request homework, the teacher may not get the message until their lunch period.

PARENT-TEACHER CONFERENCES

Scheduled parent-teacher conferences will be held in the fall. At any other time you wish to arrange a conference with the teacher about your child, please email or call the teacher to set up a mutually agreeable time to meet (24 hours in advance is preferred due to scheduling commitments).

VISITING A CLASSROOM

All requested classroom visits must be set up and approved by the teacher 24 hours in advance.

SEX OFFENDER POLICY

Vigo County School Corporation has adopted a policy prohibiting anyone who is listed on the sex offender registry from coming onto school property.

NATIONAL AND STATE TESTING IREAD 3

Law for 3rd Grade Students
Public Law 109 requires the evaluation of reading skills for students who are in grade 3 to ensure that all students can read proficiently before moving on to grade 4. The Indiana Reading Evaluation-Determination (IREAD-3) is given in the spring. The law adds retention in grade 3 if the student does not achieve a passing score on the IREAD assessment during the previous school year or during a subsequent attempt at passing IREAD-3 during the summer. IREAD is a summative assessment that measures foundational reading standards through grade 3. It is an additional assessment and does not replace any portion of the ILEARN.

ILEARN

Students in grade 3, 4, and 5 will be administered the ILEARN test will take place the weeks of April 20 through May 15th. All staff will need to provide constant proctoring to assure our students are giving their best effort on the test. Staff will need to utilize lots of positive encouragement with the students, especially during ILEARN. Let me know immediately if you have a student not putting forth effort on the test.

INDIANA CHILD ABUSE AND NEGLECT MANDATORY REPORTER

Indiana State Law requires any individual who believes a child may be a victim of abuse or neglect shall contact the Indiana Child Abuse/Neglect Hotline or law enforcement **IMMEDIATELY**.

PLEASE UNDERSTAND, THIS IS NOT A CHOICE, THIS IS THE LAW.

Certain professions, such as medical professionals, **EDUCATORS, (this includes, but not limited to, Teachers, Educational Assistants, Secretaries, Coaches, Administrators, Bus Drivers, Custodians, Cooks,etc..)** and law enforcement officials, have a higher duty of responsibility to report abuse or neglect.

Any VCSC employee who suspects that a child is being abused or neglected is to **IMMEDIATELY** report their concerns to their direct supervisor. The supervisor, with the employee, are to **IMMEDIATELY** contact the Division of Child Services at [1-800-800-5556](tel:1-800-800-5556) and Central Office to report the suspected abuse or neglect.

ACADEMIC PLACEMENT OF STUDENTS

Teachers meet by grade level during the spring of each year to determine class makeup for the following year. Factors considered include: gender ratio, academic functioning, behavioral issues, learning styles, etc. The goal is to structure well balanced classes with appropriate diversity.

TEACHER REQUEST FORMS

Parents may complete a teacher requesting form for the following year's teacher. Parents **must** list three teachers for placement consideration. An attempt will be made to honor the request for one of the three teachers. To be considered, all placement requests must be in the school office before the first day of May. Parent Input Forms will be available in the office on April 1. Please **do not** send this confidential form to school with your child unless it is in a sealed envelope.

GIFTED AND TALENTED CLASSES

The Vigo County School Corporation has adopted a program for high ability students who meet specific guidelines in grades 2-5. At the end of first grade, all students are given an initial assessment. Parents can appeal the placement decision to a broad-based committee. Contact the school office for an appeal form.

LOST CREEK PROGRAMS AND CLUBS SCOUTS

Each year, parents organize a variety of scouting opportunities for Lost Creek students. Information regarding the formation of scout troops is sent home each fall.

CHESS CLUB

Through application, students may participate weekly in the after-school club learning the fundamentals of playing and competing in the game of chess.

ONLINE MATH TEAM

The Lost Creek Online Math Team is open to 5th graders who excel at math. These students participate in online math competitions as well as the Honey Creek Middle School math completion.

BATTLE OF THE BOOKS

Selected 4TH & 5TH Grade students represent Lost Creek at the young Hoosier Book Award Battle of the Books competition. There are two competition teams, both a general education team and a GT team.

STUDENT COUNCIL

Student Council officers and representatives are elected in mid September. Student council offices are: President, Vice President, Secretary and Treasurer. They will be elected in a 4th and 5th grade election. In addition to officers, we have 1 representative and 1 alternate selected from each 4th and 5th grade classroom. All students in Student Council must maintain at least a B average in conduct and work study habits and be recommended by his/her classroom teacher.

EXPLORER'S CLUB

The Explorer's Club is an after-school science oriented club sponsored by Mr. Kirchner and Mrs. Chew. Each fall, twelve 5th grade students are selected through an application process. The club meets weekly to engage in a science-related activity. The club sponsors school-wide competitions and activities, as well as helping to care for the outdoor environment at Lost Creek.

LIBRARY MEDIA CENTER WORKERS

Students in 4th & 5th grades are chosen to help in the Library Media center with shelving books, creating book displays, and straightening materials.

ROARING READERS

Students in grades 4 & 5 are invited to participate in a weekly club focusing on a book/novel study **The Roaring Readers** meet weekly to read and discuss great books. They also fundraise to make a purchase for the media center.

RUNNING CLUBS

The Lost Creek Running Teams are designed for individuals interested in competitive running & having fun. The teams will be split into two groups. Students enrolled in grades 3-5 will be our intermediate team. Students enrolled in grades K-2 will be our primary team. A complete practice schedule and a schedule of weekend racing events will be distributed. Both teams will practice after school from 2:45-3:30.

REGISTRATION: Each year there will be a fall running season, and a spring running season. Interested runners will have to sign up for each

season during the registration window. Signing up for the fall running season, does not automatically guarantee participation on the team during the spring season. Interested students must sign up/register for each season within the designated registration window.

LONG DISTANCE LIONS

This group is meant to prepare members of the Lost Creek Running Team for April's "Swamp Stomp" at Hawthorne Park. The race consists of a **5 mile** trail run and a 1 mile fun run through the park. This group is to prepare runners for the 5 mile trail run. Space is incredibly limited for this group. Students who are interested in the group should already have experience in running. Runners should already be able to complete a 2 mile run without stopping or walking for the duration of the run. This group is reserved for 4th and 5th grade students.

MAKER SPACE CLUB

"A MakerSpace is a place where students can gather to create, invent, tinker, explore and discover using a variety of tools and materials." Diana Rendina This club is a judgement free zone. Materials such as Legos, Kinex, Osmo, craft supplies, board games, robotics, coding programs, books, computers and much more will be available for students to use freely. STEM/STEAM challenges will also be offered.

This club is for grades 2-5 and will meet on Tuesdays and Thursdays most weeks after school until 4:00. The club will start in September and run throughout the school year for varying grade levels.
